The use of online fundraising and awareness platforms expanded the reach of the event, generating greater interest for the event than in previous years. NJCASA supports policies and legislation that put survivors first and create affirming response systems. We also work with other statewide organizations to create a groundswell of support for pertinent issues. In 2019, NJCASA continued to be a strong voice with allies working toward the elimination of human trafficking, justice for survivors of child sexual assault, and survivors seeking protections through restraining orders.
